In case of any disputes arising from the lost Passbook, the Applicant solely assumes all responsibility in full and holds the Bank harmless and uninvolved. The Applicant further agrees to handle the case in the manners as enumerated below.

In case of an amendment to the standards / criteria for handling charge(s), the Bank will keep the Applicant informed in writing or promulgate the post-amendment contents through the business premises or website sixty (60) days prior to the effective date, except another term which proves more in favor of the Applicant. The Applicant is deemed to have acknowledged the amended contents unless the Applicant objects or terminates the contract before the amended contents come into effect.
